COURSE DESCRIPTION

The challenge faced by all clinicians today is to provide safe and effective dental treatment to their medically complex patients. It is imperative that all dental practitioners be equally aware of the medical considerations of agents commonly used in the practice of dentistry as well as the dental considerations of the medications frequently prescribed for the treatment of multiple systemic diseases.

This program will present an overview of dental pharmacology for the whole dental team. Special emphasis will be given to those medications prescribed or administered in the practice of dentistry whose actions, effects, or interactions with other drugs may impact treatment of systemic disease.

COURSE OBJECTIVES

Upon successful completion of this program, participants will be able to: the conclusion of the course the participant should be able to:

- Describe the pharmacology of opioid and nonopioid analgesics.
- Explain appropriate prescribing practices for opioid and non-opioid analgesics in the management of acute dental pain.
- Discuss local anesthetic agents with respect to their mechanism of action, adverse effects and contraindications.
- Examine the pharmacology of anti-infective agents commonly used in dentistry and their clinical considerations.

EVIDENCE-BASED PERI-IMPLANTITIS MANAGEMENT AND THE HARM ASSOCIATED WITH EMPIRICAL DENTAL TREATMENTS

8 Hour CE Lecture, Subject Code 690

COURSE DESCRIPTION

Peri-implantitis has been receiving attention following recent studies that showed that it is highly prevalent and difficult to manage. This course will provide the latest evidence-based information on peri-implant diseases with emphasis on a team/interdisciplinary approach to treatment. The program will present the updates on the definition and etiology of peri-implantitis from the American Academy of Periodontology's 2018 consensus meeting. The instructor will present research findings on risk factors for peri-implant disease and preventive measures to incorporate into the implant treatment plan prior to implant placement that include implant treatment planning, material selection for cementation, restorative design and maintenance. In addition, the program will review innovative evidence-driven therapeutic protocols for disease prevention and treatment and recent advancements in implant cleaning instruments and chemotherapeutics. The program will be presented by Dr. Kotsakis, Associate Professor, Periodontics, UTHealth San Antonio. His lab is a leading research center for peri-implantitis nationally and he frequently lectures on peri-implantitis research nationally and internationally.

COURSE OBJECTIVES

At the conclusion of the course the participant should be able to:

- Define peri-implantitis and diagnostic criteria.
- Explain to a patient the risk factors for development of peri-implant disease.
- Formulate an assessment and maintenance strategy for all phases of implant treatment.
- Evaluate implants and formulate approaches for prevention of peri-implant disease.
- Identify dental implants in need of non-surgical treatment and those needing referral for surgical treatment.
- Select appropriate non-surgical therapies.
- Apply basic science findings to clinical decision making.



GEORGE A. KOTSAKIS, DDS, MS

Dr. Kotsakis received his DDS from the University of Athens in Greece and practiced for several years prior to coming to the US. He completed residency in Periodontics and MS in Science at the University of Minnesota when he first got involved in Periimplantitis research. He became an Assistant Professor in the Department of Periodontics at the University of Washington. He is currently an Associate Professor of Periodontics, UTHSCA, San Antonio and Director of the ITI Scholarship Center. He is a Diplomate of the American Board of Periodontology and holds the Roland Meffert Endowed Chair in Implant Dentistry. His clinical research focuses on bone regeneration procedures in Implant surgery and Peri-implantitis Therapy. Dr. Kotsakis has published over 80 peer-reviewed scientific articles and textbook chapters with more than 13,000 citations of his work. He is one of the few Dental researchers to have been published in prestigious publications, such as the Lancet and
